CASA DE SUENOS: THE CASA DE SUENOS PROGRAM PROVIDES RESIDENTIAL CARE FOR 30 UNDOCUMENTED, UNACCOMPANIED YOUTH, AGES 12 TO 17, BROUGHT TO TUMBLEWEED THROUGH THE U.S. IMMIGRATION AND CUSTOMS ENFORCEMENT AGENCY. THE PROGRAM PROVIDES BASIC SERVICES, SUPPLEMENTED BY EDUCATION, LIFE SKILLS, ENGLISH LANGUAGE TRAINING, FAMILY REUNIFICATION, CULTURAL ACTIVITIES, AND MEDICAL CARE. THE GOAL OF THE PROGRAM IS TO MOVE THE YOUNG PEOPLE PAST THE TRAUMA THEY HAVE EXPERIENCED IN THEIR YOUNG LIVES, AND ESTABLISH THEM WITH FOSTER FAMILIES IN THE U.S. OR WITH THEIR ORIGINAL FAMILY IN THEIR HOME COUNTRY. IN THE LAST GRANT CYCLE'S FISCAL YEAR, THE PROGRAM SERVED 252 UNDOCUMENTED ALIEN CHILDREN AND 212 OF THOSE WHO LEFT IN THIS PERIOD WENT TO STABLE/SAFE PLACEMENTS.

YOUTH RESOURCE CENTERS AND STREET OUTREACH: TUMBLEWEED'S TWO YOUTH RESOURCE CENTERS ARE LOCATED IN PHOENIX AND TEMPE. BOTH CENTERS PROVIDE DAY SERVICES TO HOMELESS YOUTH, AGES 18 TO 25, OFFERING FOOD, CLOTHING, SHOWERS, LAUNDRY, ACTIVITIES, AND CASE MANAGEMENT SERVICES FOR REFERRALS AND GUIDANCE FOR SHELTER, MEDICAL CARE, EDUCATION, JOB DEVELOPMENT, AND INDEPENDENT LIVING SKILLS. BOTH CENTERS PROVIDE STREET OUTREACH A FEW NIGHTS A WEEK, TAKING FOOD, WATER, HYGIENE SUPPLIES, AND CLOTHING TO THE HOMELESS YOUTH WHERE THEY CAN BE FOUND ON THE STREETS AND IN THE NEIGHBORHOODS, AND ENCOURAGING THEM TO ACCESS THE YOUTH RESOURCE CENTERS. STREET OUTREACH MADE 2866 CONTACTS IN MARICIPA COUNTY AND 287 INDIVIDUALS RECEIVED INTENSIVE CASE MANAGEMENT AT THE RESOURCE CENTERS, WITH OVER 3,205 UNDUPLICATED YOUTH VISITING THE CENTER.

OPEN HANDS: THE OPEN HANDS PROGRAM HAS BEEN PROVIDING CRISIS SHELTER TO YOUTH AGES 12 THROUGH 17, SINCE TUMBLEWEED FIRST OPENED ITS DOORS IN 1975. THE PROGRAM PROVIDES CRISIS INTERVENTION, SKILL-BUILDING AND COUNSELING FOR YOUTH AND THEIR FAMILIES, DURING DIFFICULT TIMES IN THEIR LIVES. THE YOUTH ENGAGE IN ON-GOING EDUCATION OR TUTORING WHILE THEY ARE RESIDING AT OPEN HANDS, AND EXPERIENCE STABILITY, ACTIVITIES, AND CARE WHILE THEY WORK ON FAMILY REUNIFICATION OR ALTERNATIVE PLANS FOR THEIR FUTURE. THE PROGRAM SERVED 215 UNDUPLICATED YOUTH WITH 80% LEAVING TO PERMANENT HOUSING AND 17% LEAVING TO TRANSITIONAL PLACEMENTS SUCH AS THE YOUNG ADULT PROGRAM AND GROUP HOME/FOSTER CARE.
